THE HIGHLIGHT OF FY19 WAS UNDOUBTEDLY THE MUSEUM'S LANDMARK EXHIBITION ANDY WARHOL - FROM A TO B AND BACK AGAIN. WHITNEY EDUCATION'S GOALS FOR PROGRAMMING WERE TO INTRODUCE WARHOL AND HIS ART TO A NEW GENERATION OF ART LOVERS, WHILE MAKING CONNECTIONS WITH AUDIENCES WHO WERE ABLE TO RELATE TO HIS "OUTSIDER" STATUS AND UPBRINGING. SPECIAL PROGRAMMING INCLUDED OUR YOUTH-ORGANIZED QUEER TEEN NIGHT, WHICH GATHERED TEENS FOR ART-MAKING, PERFORMANCES WITH ARTIST RAJA FEATHER KELLY, SNACKS, AND TOURS OF WARHOL. THE DEPARTMENT ALSO HOSTED A SERIES OF ARTMAKING WORKSHOPS WITH THE LOWER EAST SIDE PRINT SHOP TO GIVE FAMILIES, STUDENTS, AND COMMUNITY MEMBERS THE OPPORTUNITY TO LEARN FIRST-HAND ABOUT WARHOL'S SIGNATURE SILKSCREEN TECHNIQUES. PUBLIC PROGRAMS ORGANIZED A SYMPOSIUM IN PARTNERSHIP WITH THE NEW SCHOOL ENTITLED ANDY WARHOL AFTER POP THAT BROUGHT TOGETHER SCHOLARS, CURATORS, AND ARTISTS TO REASSESS WARHOL'S LATER WORK FROM 1968 UNTIL HIS DEATH IN 1987.

IN FY19, THE DEPARTMENT OFFERED THE FIRST EVER ART COLLEGE NIGHT FOR NYC TEENS AT THE WHITNEY MUSEUM, IN WHICH REPRESENTATIVES FROM COLLEGES IN THE NEW YORK AREA GAVE INFORMATION ABOUT SCHOLARSHIP OPPORTUNITIES, COLLEGE ESSAY WRITING TIPS, AND MUCH MORE.

OTHER INNOVATIONS FROM THE YEAR INCLUDE THE DEVELOPMENT (WITH THE MUSEUM'S DIGITAL TEAM) OF A PROGRESSIVE WEB APP THAT MAKES THE MUSEUM'S INTERPRETATIVE CONTENT EASILY ACCESSIBLE USING VISITORS' OWN PHONES RATHER THAN RENTAL DEVICES PROVIDED BY THE MUSEUM. WITH THIS

TECHNOLOGICAL ADVANCE, OUR OVERALL AUDIENCE FOR AUDIO CONTENT ON SITE AND ON WHITNEY.ORG INCREASED 4.3X FROM 2,200 USERS A MONTH TO 9,400 MONTHLY USERS BY THE END OF THE YEAR. THE DESIGN OF THE NEW MOBILE INTERFACE MADE OUR AUDIO TRANSCRIPTS, SOUND DESCRIPTIONS, AMERICAN SIGN LANGUAGE AND NEW VERBAL DESCRIPTION TOURS EVEN MORE ACCESSIBLE TO OUR DIVERSE AUDIENCES, INCLUDING THOSE WITH DISABILITIES.

ANOTHER IMPORTANT FOCUS THIS YEAR WAS OUR PILOT PROJECT TO PROVIDE INTERPRETATIVE MATERIALS IN SPANISH FOR AN EXHIBITION OF CONTEMPORARY LATINX ART CALLED PACHA, LLAQTA, WASICHAY. THE SPANISH LANGUAGE WALL LABELS WERE A CRITICAL PIECE OF THE EXHIBITION, NOT ONLY BECAUSE AS THE ARTISTS THEMSELVES MOVE FREELY IN AND OUT OF ENGLISH AND SPANISH CONTEXTS, BUT ALSO BECAUSE THESE LABELS ENABLED MEANINGFUL ENGAGEMENT FOR SPANISH-SPEAKING TOURISTS AND LOCAL AUDIENCES. EDUCATION AND CURATORIAL CONDUCTED SEVERAL FOCUS GROUPS DURING THE RUN OF THE EXHIBITION. WE FOUND THAT THE DUAL LANGUAGE TEXTS WERE VERY WELL-RECEIVED, AND THAT FIRST-TIME SPANISH-SPEAKING VISITORS FOUND THE WHITNEY MORE WELCOMING AND ACCESSIBLE ON ACCOUNT OF THE PRESENCE OF THEIR NATIVE LANGUAGE. THIS PRACTICE OF PROVIDING BILINGUAL WALL LABELS CONTINUED THROUGH THE WHITNEY BIENNIAL AT THE END OF FY19, AS A WAY OF ACHIEVING THE MUSEUM'S STRATEGIC GOALS OF BUILDING AND DIVERSIFYING AUDIENCES.

OUR PUBLIC PROGRAMS CONTINUE TO PROVIDE AN OPPORTUNITY FOR IMPORTANT CULTURAL AND POLITICAL VOICES TO JOIN THE ARTISTIC CONVERSATION, AND PRODUCED SEVERAL PERFORMANCES IN FY19, INCLUDING THE OG OF UNDOCUMENTED CHILDREN BY GUADALUPE MARAVILLA, ITSOFOMO (IN THE SHADOW OF FORWARD MOTION) BY BEN NEILL, DISTRIBUTED WEB OF CARE BY TAEYOON CHOI, AND A

FY19 MARKS THE FOURTEENTH YEAR OF THE ANNUAL WALTER ANNENBERG LECTURE, WHICH HONORED KARA WALKER.

THIS YEAR THE MUSEUM ALSO LOOKED AHEAD TO THE FORTHCOMING INSTALLATION OF DAVID HAMMONS'S DAY'S END, A PUBLIC ART PROJECT THAT WILL BE LOCATED IN HUDSON RIVER PARK ALONG THE SOUTHERN EDGE OF GANSEVOORT PENINSULA DIRECTLY ACROSS FROM THE MUSEUM. IN FY19, THE MUSEUM CONTINUED TO BUILD OUT A VARIETY OF DIGITAL INTERPRETATIVE MATERIALS RELATED TO DAY'S END AND THE NEIGHBORHOOD THAT WILL BE AVAILABLE TO THE PUBLIC FREE-OF-CHARGE ONSITE AND ONLINE. THESE MATERIALS INCLUDE NEW AUDIO AND VIDEO CONTENT INTRODUCING DAVID HAMMONS, GORDON MATTA-CLARK, AND THE HISTORY OF THE GANSEVOORT PENINSULA OVER THE CENTURIES, THEMATIC NEIGHBORHOOD WALKING TOURS WITH DIFFERENT THEMES, AN ORAL HISTORY PROJECT THAT WILL COLLECT AND PRESERVE LOCAL STORIES, INDIGENOUS SITE RESEARCH, AND AN ONLINE HUB THAT WILL OFFER A DEEPER DIVE INTO HAMMONS' ARTWORK AND THE HISTORIES OF THE NEIGHBORHOOD.
